ADMINISTRATIVE ORDER  
NO. 2013-00 75

**WHEREAS**, in counties having three or more superior court judges, the presiding judge may appoint court commissioners to serve at his pleasure, who shall have such powers and duties as shall be provided by statute or by rule of the supreme court;

**WHEREAS**, The Presiding Judge having previously appointed Dwight P. Callahan as a part-time Commissioner of the Superior Court; the Pinal County Board of Supervisors having reclassified this position to full-time status at the request of the Presiding Judge; the Presiding Judge having invited public input on the question of whether to reclassify Commissioner Callahan to full-time status, including posting and holding a public hearing on this question; and the Presiding Judge having received unanimous public recommendations for the reappointment of Commissioner Callahan to full-time status; and,

**WHEREAS**, the *Executive Committee* having rendered its advice and counsel to the Presiding Judge, who has considered that advice and counsel and the particular needs of the Superior Court, and the Presiding Judge having determined that Commissioner Callahan should be reappointed to serve as a full-time superior court commissioner;

**IT IS HEREBY ORDERED**, *nunc pro tunc*, reappointing Commissioner Dwight P. Callahan as a full-time Superior Court Commissioner for Pinal County for a period from September 1, 2013, and ending June 30, 2014, subject to annual reappointment by the Presiding Judge, pursuant to Section 12-213, *Arizona Revised Statutes*; compensation shall be paid at 80% of the compensation paid to a Superior Court Judge; the Superior Court Commissioner shall serve at the direction and pleasure of the Presiding Judge of Pinal County.
