RE: Amending – The Appointment of the Pinal County Committee on Court Facilities

Upon request of Pinal County executive branch officials, I've established the Pinal County Committee on Court Facilities to review and assess the needs for court facilities in the future. This assessment will address facility requirements for judicial branch departments including Superior Court, Clerk of Superior Court, Adult Probation, Juvenile Services, and Justice Courts.

The Committee will work with the DLR Group and National Center for State Courts to address the following needs: (1) revise/update the Superior Court of Pinal County Capital Improvement Committee Report and Recommendations Final Report from January 2007; (2) analyze the potential for expansion of Pinal County Courthouse and/or possible development of decentralized "satellite courts" in other county population areas; and (3) recommend improvements for enhanced security of judges, staff and the public at existing court facilities.

Attached is a new Administrative Order No. 2014-000___, amending Pinal County Superior Court Administrative Order No. 2014-00014 which confirms the purpose and appointment of the Committee, and adding Public Defender, April Elliott to the Pinal County Committee on Court Facilities.
