**WHEREAS** the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the chief judicial officer of the county and has administrative authority over all the courts in Pinal County, pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2005-32 (revised May 16, 2005); and,

**WHEREAS** the Honorable Shaun Babeu, Justice of the Peace, Precinct No. 7 has requested the appointment of Bradley Grover, Robert Huddleston and Paul Julien; and

**WHEREAS** the Presiding Judge finds that the afore-listed request for appointments is necessary, appropriate and in the best interest of the Judicial Branch of Government in Pinal County;

**NOW, THEREFORE** pursuant to A.R.S. § 22-121(B),

**IT IS HEREBY ORDERED**, that **BRADLEY GROVER, ROBERT HUDDLESTON** and **PAUL JULIEN** be and they are hereby appointed to serve as Justices of the Peace *Pro Tempore* for a period commencing January 1, 2015 and ending December 31, 2015.

**IT IS FURTHER ORDERED** that **BRADLEY GROVER** and **ROBERT HUDDLESTON** be compensated in accordance with state law; payable through funds budgeted in the Judicial Branch and/or the Justices of the Peace for such purposes. **PAUL JULIEN** shall receive no additional compensation or benefits other than the compensation and benefits he receives as a result of his status as a full-time employee of the Arizona Supreme Court.

This appointment is at the pleasure and direction of the Presiding Judge of the Superior Court. Such appointment may be terminated without cause at any time by the Presiding Judge.
