His powers as a Special Commissioner are limited to considering and determining applications filed pursuant to A.R.S. § 12-302 requesting deferral of filing fees, service of process fees and other fees pursuant to A.R.S. § 12-284 and signing an Order for Deferral.

**IT IS FURTHER ORDERED** that this assignment is conditioned upon the agreement by **Matt Helm** to serve as a Special Commissioner for this designated matter only and to do so for no additional compensation or benefits, fiscal or otherwise.
