ADMINISTRATIVE ORDER

NO. 2017 - 00 027

WHEREAS, in February of 2017 the Supreme Court of the State of Arizona adopted statewide court security standards and related recommendation for the implementation of those standards, Administrative Order No. 2017-15;

WHEREAS, there is a three-year period for the for the mandatory implementation of these standards beginning July 1, 2017;

WHEREAS, this is an integrated judiciary and collaboration and coordination with all stakeholders is necessary for true system improvement. The *countywide* Court Security and Emergency Preparedness Committee (SEPC) is charged with setting goals for the implementation of the court security standards, the review of local security plans and self-assessments, coordination of security needs countywide, and ensuring continuous court security improvement;

WHEREAS, it is recognized that each court building or court complex has unique needs, *local* SEPCs may be established as approved by the countywide Court Security and Emergency Preparedness Committee. Local SEPCs functions may include, but are not limited to, implementation of court security standards adopted by the Arizona Supreme Court, development and allocation of resources necessary for security needs; and coordination of security self-assessments, security drills, and testing of security equipment.

WHEREAS, adopting best practices and implementing innovative approaches that improve the safety and security of court users and staff contribute to a better court experience;

NOW, THEREFORE, IT IS ORDERED that the countywide Court Security and Emergency Preparedness Committee be established and that they meet no less than twice each year. To meet these needs, the persons listed in Appendix A are hereby appointed to this committee. The members in Appendix A are being appointed by virtue of their positions. Additional members may be appointed as necessary.
