ADMINISTRATIVE ORDER

**WHEREAS** the Presiding Judge of the Superior Court of Arizona in and for Pinal County is the Chief judicial officer of the county and has administrative authority over all courts in Pinal County, pursuant to Article VI of the Arizona Constitution and Arizona Supreme Court Administrative Order No. 2017-79; and

**WHEREAS** the court failed to include the matrix for the assignment of new civil cases, therefore,

**NOW, THEREFORE, IT IS ORDERED** affirming all current duties and assignments of all full-time and part-time judicial officers of the Superior Court, except where modified by this Administrative Order, effective March 12, 2018.

**IT IS FURTHER ORDERED** that all new Civil files (identified by the prefix (CV), regardless of the specific case type, filed on or after March 12, 2018, shall be assigned to the Hon. Steve J. Fuller (SJF), Hon. Brenda E. Oldham (BEO) and the Hon. Stephen F. McCarville (SFM), as determined by the two terminal digits of each new Civil file, as follows:


