

# MOTION AND ORDER TO CONTINUE ON THE INACTIVE CALENDAR

## WHEN FILING A MOTION AND ORDER TO CONTINUE ON THE INACTIVE CALENDAR THE FOLLOWING IS REQUIRED:

1. A motion and order to continue on the inactive calendar should be submitted at least (3) weeks prior to your court hearing.
2. Please complete both forms in black ink only.
3. Once forms are completed, date and sign the form.
4. After dating and signing the form, you will make a copy of both the motion and order to continue on the inactive.
5. You will bring the original and copies of the motion and order to continue on the inactive calendar to the court for filing.
6. You will also bring a ***self-addressed stamped envelope***. The envelope will be addressed to you.

The motion and order to continue on the inactive calendar will be sent to the Judge for review. The Judge will review the motion, if approved the Judge will sign the order granting the continuance. You will receive a copy of the order to continue on the inactive calendar by mail.
